1. The tournament is open to all active WAP members of the RECURVE CADET MEN and WOMEN CATEGORIES **born on or after 01 January 2001 and on or before 31 December 2013.**
2. Accepted proof of birth record is: a clear copy of NSO birth certificate &/or passport.
3. WAP will start accepting entries on 05 January 2017 but not later than 10 January 2017.
4. Entry fee is PhP 500.00 to be deposited to:

5. To finalize entries, the following documents must be sent AT ONE TIME thru email to rcsombriosecgen@gmail.com:
  - a. entry form (we encourage the use of 1 entry form per team / club)
  - b. validated Security Bank deposit slip (archer's name should be indicated in the slip)
  - c. clear copy / scanned copy of proof of birth record
6. Failure to accomplish any of the above-mentioned requirements will be considered INVALID ENTRY. No on-site registration will be accepted. Payment is Non-Refundable.
7. Archers will shoot 72-arrow 60-meter recurve ranking round.

9. **QUALIFICATION PATHWAY**
  - a) The Youth Olympics Games (YOG) Qualification Tournament and the 2017 World Archery Youth Championships are separate competition for those athletes who are eligible to compete in the YOG 2018.

- b) WAP may enter THREE (3) YOG aged athletes per gender in the YOG Qualification Tournament and the 2017 World Archery Youth Championships, but will depend on POC's & PSC's other related criteria.
- c) The series of WAP's Youth Olympic Trials will determine the top 16 best-ranked athletes in each gender who will qualify to complete in the WAP's finals selection tournament and/or have garnered the set MQS as follow:

RECURVE CADET MEN	-	630 points
RECURVE CADET WOMEN	-	620 points

- d) **WAP's final selection** of the THREE (3) ATHLETES PER GENDER will be based on the point system set by WAP computed from a 72-arrow at 60-meter and an Olympic Round tournament. Date of the final selection will be announced in good time.

10. WAP reserves the right to modify the selection process if deemed necessary.
